Dear all,

We trust that you and your families are well and safe in dealing with this horrible pandemic that has claimed the lives of so many people around the globe and has changed the way we conduct ourselves in our daily activities.

Based on the Bylaws of H.A.N.C., your term as president and the term of the executive board has expired and you are operating on your own and without a mandate from the General Assembly of H.A.N.C.

Moreover, according to the Bylaws of H.A.N.C. elections are mandatory to be called every two years, and a full Treasurer's report should be given annually. However, you failed to do so.

The current Board of H.A.N.C. was elected in October 2015. Elections should have been held in October 2017. It is clear, that your term expired three and a half years ago.

As a result of the above, we the presidents of the federations, stated at the end of this letter, are calling according to H.A.N.C.'s Bylaws a **Presidents' Forum Special Meeting.** 

Given that you have no authority to act and present yourself as an elected officer of H.A.N.C., the undersigned Federation presidents, based on section 5 b of ARTICLE V, demand the following:

- a) Effective immediately and mandatory, you and your board, cease and desist to present yourselves as officers of H.A.N.C. Failing to do so may lead to serious legal consequences.
- b) If anyone from the board who has resigned or has been terminated, may acknowledge the Presidents' Forum simply by replying to this email and by stating the resignation / termination.
- c) You are requested to participate in the teleconference of Presidents' Forum, scheduled on the **6**<sup>th</sup> **of February 2021 @ 3:00 PM Eastern Standard Time** (details for the connection and time will be sent on personal emails on February 1<sup>st</sup> 2021).
- d) In this meeting, **the Presidents' Forum** will take under consideration the current status of H.A.N.C. and will take the necessary steps for the future of H.A.N.C., such as the exact date of elections, the transitioning administration, and form the election committee.
- e) Elections must take place within 60 days from the 6<sup>th</sup> of February 2021.
- f) Bill Matarangas acting as President is demanded to appear in person in the teleconference.
- g) H.A.N.C. Secretary Dr. P. Baltatzis is requested to have available for immediate delivery the documentation (meeting agendas, minutes, etc.) beginning on your election date of October 2015 to today, as well as the website domain credentials, the seal of the organization, etc.

- h) H.A.N.C. Treasurer Mr. K. Hatzistefanides is requested to present the financial report and fillings as well as any bank accounts for immediate delivery.
- i) In case (f), (g) or (h) points are not satisfied, the Presidents' Forum will initiate legal action the next day of the President's Forum Meeting, including an update to State Attorney's office.

H.A.N.C. was founded to unite Hellenic organizations in the United States of America, to promote Hellenic values and to help the homeland and the Hellenic Nation, at any challenging times such as now, with a President, and a Board of Directors accepted and legally elected so that all member federations feel represented.

This letter is copied to The Prime Minister of Greece, the Minister of External Affairs of Greece, the Minister of Greeks abroad, the General Secretary of Public Diplomacy & Greeks abroad, the Greek Embassy in Washington, as well as to the Archdiocese of America.
